ByLaws

A proposal to change the by-Laws was brought before the Board. (bolded type)

Section 5 (b) Elections

*Elections.* A ballot shall be made available to the members in good standing not more than thirty (30) days nor less than twenty days (20) in advance of the Annual Meeting. All voting shall be by mail or secure electronic format and all ballots must be received by the Secretary, in care of the Regional Office, at least four (4) days before the date of the Annual Meeting.

**However, if the number of nominees for the position of Director or Regional Executive equals but does not exceed the positions to be filled, the nominee or nominees shall be deemed elected, and no ballot for those positions shall be submitted to the membership. If no nomination for Regional Executive is received, or if fewer than the required number of nominations for Director are received, the elected Members of the Board shall fill those positions by appointment, and no ballot for those positions shall be submitted to the membership. [to be added]**

Gary Pitts moved to amend the by-laws as written, second by Clint deWitt. Defeated three votes against, two votes in favor.

Anthony Tabacco moved to change the by-laws as follows:

**If no nomination for Regional Executive is received, or if fewer than the required number of nominations for Director are received, the elected Members of the Board shall fill those positions by appointment, and no ballot for those positions shall be submitted to the membership**

Mike Smith seconded this motion. Motion carried.

## Formula Ford the Series

Blake received E-mail from Norm Marshall. He wants to start an annual Ford Heritage Event that will feature cars designed and raced around the Ford Cortina, Kent, and Z-Tec Motor. He wanted to know the region's interest in putting on such an event at Laguna in the early fall.

The event would feature Vintage and Current Formula Fords, Formula Continental, and F2000 type cars.

The board was skeptical about the idea, doubting the ability to attract enough entrants to make the event financially sound.

Another issue would be the club would be giving up two of the variable sound days we receive from Mazda Raceway. IN order for the club to do something along those lines it would have to make sense for the overall membership.

The board was not closing the door and would be willing to hear more from Mr. Marshal.

Blake was going to communicate with Mr. Marshall and see if he wants to make a formal presentation.

Blake also talked to John Barron who is a participant in the group Formula Ford the series. He and Norm were interested in getting their cars allowed to run in our regional races especially at Laguna Seca. John said that the SCCA National Office has already approved their rules as a regional class and the Arizona Region of the SCCA has adopted their rules and they are invited to run this December at Chuckwalla Valley Raceway.

The board was willing to add a separate regional class for **Formula Ford the Series** if their rules are within the GCR and their cars can pass tech which would include having a logbook. More discussion and a close look at the rules and the cars that the group would bring will be the final pieces to add.
