Meeting called to order at Vic's All-Star Kitchen at 11:05 AM.

- 1. Treasurer's Report (Tim Sullivan)
  - YTD: \$144,580
  - Sonoma Regional: \$46,002
    - Test Day
      - (1) 9 drivers added an extra session
      - (2) 108 entrants
    - Races
      - (1) 212 entries;176 unique drivers
    - (2) 36 dual entries
  - Projected Super Tour: need ~80 more registrants to break even
  - Trans Am Status:
    - As-yet unpaid
    - Terry indicated we'd have a check by the end of June. No reply to phone calls or e-mails since
    - We will contact Tony at TransAm to get payment
    - TransaAm had a three year contract at Laguna. It does not include workers. TransAm received a 25% discount over Laguna charges for staffing
  - Bank Accounts:
    - Bank of Commerce CD matures 15-Aug-2019; funds will be moved to Edward Jones
    - (1) One account has already been moved. New CD purchased: 12 months at 2%
    - Additional CDs maturing roughly monthly through December
  - David Vodden presented the Region with a \$50,000 sponsorship check for 2019

- 2. Sonoma Regional Issues (Tim Sullivan, Bill Blake)
  - Driver feedback: the Board received 3-4 letters regarding driver safety issues
  - Safety
  - Driver accountability
    - "I get punted and he goes on to win the race, while I'm sitting on the side of the road. He wins and there are no repercussions"
    - With us, people do things and there are no repercussions
    - Race Admin gets a list of who is on Probation and Suspension; this list is checked upon driver check-in
    - Body contact: automatic review without protests/black flags
    - Drivers often don't want to initiate a protest. Why? Friends don't want to cause issues with friends or shops
      or, generally, others within the community.
  - Repercussions
    - SCCA points system
      - (1) National tracks points
      - (2) When was the last time we suspended someone's license due to points?
      - (3) System
        - (a) Assessed at Tech: loss of on-track position, no points assessed
        - (b) Goes to SOM: points assessed against the license
        - (c) Protest: points assessed against the license
  - Onboard cameras: Require
    - Ten years ago, this wouldn't have been feasible
    - Now, technology has advanced and is cheap enough to make this possible
    - Other racing organizations have set this precedent:
      - (1) NASA
      - (2) Pro racing: Mazda
    - This would include the use of the 3rd and 4th car videos behind the offending cars, which would have the best view.
  - Revision to Region Supplemental Rules
    - Supps can be changed to require onboard cameras
      - (1) not currently in the GCR
    - Language for 2019 will be entered as "strongly recommended," then change to "required" in 2020
    - Bill Blake suggests we speak to Dave Arkin, on the Competition Board
    - Might need to implement this policy as a proof of concept to show National
  - Implementation
    - "As a result of member input, the Board has looked into the prospect of requiring the mounting of forward-facing cameras on participants' cars." We will amend supps to reflect this
    - Enlist a small team to review onboard footage when drivers come through Impound
    - Bring back driver observers We will ask drivers via survey if they will want to implement Driver Observers. Brad Dressan had indicated on social media he would be ok with this
    - Corner workers are too busy to do double-duty
      - (1) Must be Drivers not driving at that regional-only race
      - (2) If a Driver Observer sees a problem and the Driver doesn't want to pursue it, do we still take action? Yes: this isn't personal, the rules must be followed.
      - Can we have a meeting where the Stewards explain what they do on-track?
      - Drivers don't know how the process works; education will help interactions between Drivers and Stewards
    - Can we utilize The Wheel?
    - Driver School
      - (1) Noted many times in the Facebook discussion as being deficient
    - Is there any advantage in identifying "problem drivers"?
      - (1) Stewards' current process is to cycle through the different stewards' roles. Lack of consistency in personnel/specialty assignment prevents the Steward from identifying problem people.
    - Time constraints for a protest: what if it takes longer to resolve than 30 minutes?

- (1) 30-minute limit is to initiate the process, not to resolve it.
- (2) Participant can initiate a protest and take the time needed to collect information/evidence.
- (3) Stewards must take time to review and assess evidence; this might take longer than race day.
- Post-session drivers' meeting? In Impound, directly after your session.

- 5. Race Report/Status ALL
  - Super Tour
  - Regional 11/12 Labor Day Laguna
    - Schedule has been approved regionally and sent to National for Sanction
  - Regional 13/14/15 Thunderhill
    - Will advertise via The Wheel and via social media
  - 2020 schedule
    - Track notes for next year
      - (1) Laguna will be shut down for a month next year; still no news as to which particular month
      - (2) Sonoma knows we want at least two dates
        - (a) Will not get July 4th, as that is on a Saturday
        - (b) Can we do three? (No)
      - (3) Thunderhill will work with us for scheduling
    - Variable groups?
      - (1) Formula classes are sensitive to their groupings
        - (a) If we mix who the classes run with, would more drivers attend our races?
      - (2) Include Drivers in the discussion (Facebook, e-mail)
      - (3) If we offer changes/variables, will that generate interest?
- 6. Race Classes
  - Classes to eliminate No entries in three years
  - List generation Responsibility (Nan/Youmna will generatie list)
  - MC Class Laguna Regional 11/12
    - Hope to have National's blessing so the new class can run
- 7. Year End Awards Program David
  - Drivers Awards
    - To be awarded at the Banquet, in a random drawing
      - (1) Open to 2019 class winners
