Their representatives will come to Laguna Seca for the July 24-26 race. The current proposal would be for them to be a sponsor of the PCRRIC in 2016.

Stockton Fairgrounds site development – Blake and Tony met Kelly Olds who is the CEO of the Stockton Fairgrounds. Tony presented a proposal for an expanded autocross site at San Joaquin County Fairgrounds. Tony and Blake will continue research into particulars of site development, interaction with the government entities involved, and development of a detailed proposal for the project.
