

Waiver or Credit for Previous Racing Experience

If you are new to the SCCA and currently hold a competition license with another organization or perhaps you you've been away from racing for the last couple of years, you may request a waiver to obtain a license, based on your experience. Depending upon your previous racing experience, some or all your licensing requirements may be waived. Here are the steps:

- 1. To request a waiver, submit your <u>racing resume</u> including copies of currently held licenses and race results to the Divisional Licensing Administrator based on your primary address. (listed below). If approved, the DLA will notify SCCA Member Services.
- You will also need to sign up for a SCCA Membership, and upload the required SCCA forms (<u>Medical Form</u> & <u>License Application</u>) from your profile page under My Documents. You may also complete the digital annual participation waiver (<u>instructions</u>) while you're at it. To do this, visit <u>my.scca.com</u>. If you are already a member, log-in to your Member Account. If not, click the JOIN NOW button.
