## SFR Board of Directors Meeting Minutes October 14, 2025

Mike opened the meeting at 5:30 PM. Members in attendance were Blake Tatum, Bill Booth, Greg Hoff, Mike Smith and Linda Rogaski. Joe Montana was not in attendance.

### Minutes

Greg motioned and Bill seconded the September minutes be approved as posted. The motion passed.

### Finances

Bill stated that year-to-date we are \$26,000 to the good. At this point in 2024 we were at a \$150,000+loss. Bill stated given our goal to halve our 2024 losses, we are ahead of plan.

Bill reported:

- The September event lost \$28,000, driven primarily by low entrant numbers.
- This is the second month operationally and overall that we have been profitable. But, of course, we have one more event, the Banquet, Year-end trophies, and other expenses before year end.
- To date we have paid out \$64,800 in worker stipends. In parallel, several workers have elected not to take the stipend, representing \$29,700 in value.

Bill also stated we need to do a plan on doing a physical asset review.

### October Event

The numbers are looking good for both the regional event and the enduro. Greg has found trophies from the Livermore storage unit we can use as enduro trophies. He has ordered plates. First place class winners will receive the trophies and second and third place winners will receive medallions.

Dottie will send a blast out encouraging people to sign up for the weekend.

### 2026 Schedule

Mike shared a tentative 2026 schedule. Drivers School will be in February 10-21, with a slightly different format. Friday afternoon will be class room instruction only with Saturday and Sunday on track. SFR events:

- March 27-29 a Regional at Thunderhill
- April 25-26 a Majors Thunderhill
- May 15-17 Thunderhill will host the First Annual Thunderhill Open. The format will be similar to a Gridlife event
- May 15-17 National staff will conduct a SCCA National Time Attack event. Workers will not be needed for either of these events
- June 26-28 Laguna Regional and September 4-6 Regional at Sonoma. Both of these events are tentative waiting for track approval.
- The season will end with a Regional/Enduro at Thunderhill.

Mike is going to check with National to see if they would move The Time Attack to a September date so we could host a Regional in May.

Mike suggested that board members reach out to other organizations i.e. Crossflow, Rush, Corvettes, etc. to determine what events they might be interested in running with us. We can then determine if those dates will work.

### West Coast Region Calls

Mike is continuing to participate in calls with the West Coast Region RE's and members. They are sharing recaps of classes and activities. They are going to share financials with the goal of helping each other host successful events.

**Elections**

Balloting opens October 18 and closes November 3. National is handling the election process. They have sent out one notice, another will go out on Friday October 18, another in the middle of the election cycle and again at the end to remind people to vote.

**Board Vacancy**

It was agreed that the Board would wait to fill the vacancy until after the election, so newly elected members could have a say.

**Annual Meeting**

The annual meeting will be held on zoom on November 8th at 1:00 and the Board will meet, via zoom, at 10:00 AM that morning to welcome newly elected members.

**December Board Meeting**

The Board will meet in person on December 4, at 10:00 at the Mercedes Benz dealership in Stockton.
